** Applies for students commencing 2022 and beyond. Students enrolled prior to 2022 will have their enrolment bond credited to fees when reaching Year 7 (for students Years 1 to 6) or Year 12 (for students Years 8 to 11).

The Annual Fee incorporates but is not limited to photocopying, classroom/library consumables, learning software, excursions and compulsory camps, visiting artists, swimming lessons, sports equipment, cultural events, travel to sports carnivals, and one College Magazine - 'Focus' - per student. The Mt Binga Outdoor Education Camp is compulsory for all Year 9 students. The cost of this camp, which is split across two years when the student is in Year 8 and Year 9, is itemised separately on the fee statement.

The Annual Fee is prorated for students commencing enrolment during the College year.

Capital Levy

The compulsory **Capital Levy is \$550 for each family**. This levy assists the College in funding capital expenditures such as purchasing of furniture, equipment and air conditioners for classrooms, and maintenance of facilities. As a compulsory levy, tax deductibility is NOT available. However, we still maintain a tax-deductible School Building Fund, which is available for those families who wish to make additional contributions for tax purposes. In addition, this contribution will assist the College to provide a better environment for their children and subsequent generations.

Community Levy

Funds raised with this levy support community events and initiatives during the school year (eg Welcome BBQ, Class Carer Program) as well as providing funds for major student focussed capital projects. In previous years these projects have included the redevelopment of the Lighthouse, upgrade to the Koala Gums Play Area (Junior Campus) and the Fitness Equipment (Secondary Campus).

Concessions

Fee concessions are available on a means tested basis for instances of short term genuine financial hardship. Parents can apply for these concessions through the Business Office. In times of financial difficulties parents should contact the College Business Office to develop a solution for their situation.

Payment of Fees

Enrolment at Faith is on an ongoing yearly basis until completion of Year 12 (subject to withdrawal as per 'Notice of Withdrawal' below) and annual fees are payable. In each year, continued enrolment is subject to the Annual Fee Schedule (and conditions therein) applicable to that year.

Fee Payment

- Fees are billed on an annual basis, and parents can nominate their preferred frequency of payment from the following:
 - Whole year payment. Parents may choose to **pay the whole year's fee by Friday, 23 February 2024 and receive a 4% discount** on tuition fees. The discount does not apply to other costs or levies (eg Mt Binga, Capital Levy, Community Levy) or where other financial assistance has been provided (ie concessions).
 - By instalments - weekly, fortnightly, monthly or quarterly via School EasyPay (accessed via Parent Lounge).
- **Fees can be paid by:**
 - BPay through your bank via internet or telephone banking. BPay details are included on the Annual Fee Statement.
 - Parent Lounge by following the link included on the Fee Statement.
 - School EasyPay – by instalment (accessed via Parent Lounge).

Please note that over the counter payments via EFTPOS, Credit Card or Cash will only be accepted at our Beveridge Road Campus.

Stationery Items

Stationery items such as books, pens, pencils and textbooks are supplied by the College (covered by the Stationery Levy). In 2024 this levy includes an Oxford Maths Workbook for all primary students.

eLearning Device Program

The College operates a BYOD program for students. Devices may be purchased from The School Locker or JB Hi-Fi at educational pricing. Further details are provided in the eLearning Information Booklet available on our College website at <http://faithlutheran.qld.edu.au/our-college/elearning-isc>.

College Resources – replacement of damaged resources

Faith has resources and materials that it loans for student use. If resources are damaged or lost and need to be replaced, parents may be invoiced for the original cost (not the replacement cost).

Notice of Withdrawal

One full term's written notice to the Principal is required to withdraw a student. The notice of withdrawal can be emailed to principalpa@fcr.qld.edu.au. For a student leaving at the end of the year, (excluding Year 12), notice is required by the 1st week of Term 4. Where insufficient notice is received the enrolment bond will be forfeited and an additional term's fees will be charged.
